

Warranty Policies

THERE ARE NO UNDERSTANDINGS, AGREEMENTS, REPRESENTATIONS, OR WARRANTIES EXPRESSED OR IMPLIED (INCLUDING BUT NOT LIMITED TO ANY REGARDING THE MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE), NOT SPECIFIED HEREIN, REGARDING THE EQUIPMENT WHICH IS THE SUBJECT OF THIS WARRANTY.

Owner/Operator Knowledge Responsibility

As a condition of the Dixie Chopper warranty, the owner and operator(s) are fully responsible for having read, and reasonably understanding the proper operation and care of the Dixie Chopper unit *Before Attempting to Operate the Machine*.

Through the terms and conditions contained herein, Magic Circle Corporation (Dixie Chopper) warrants that it will adjust, repair, or replace, any factory original part used in the manufacturing of a Dixie Chopper complete unit, found to be defective in material or workmanship.

Complete Unit - All Models (excluding Silver Eagles)

The warranty period is limited to two years from the date of retil purchase on behalf of the original owner of a Dixie Chopper complete unit. This warranty will provide the cost of repair or replacement (at the discretion of Dixie Chopper) of the defective part, including labor. This warranty applies in like form to the original retail purchaser of a Dixie Chopper complete unit used commercially, or for income producing purposes. Additionally, Dixie Chopper will provide to the original purchaser beyond the initial2yrs warranty as stated above, replacement of any main-frame, front fork and castor bearings, steering levers and linkages due to breakage, or any stainless steel body due to rust, for the useful life period of the machine. This additional "lifetime warranty" covers stated parts only... no labor

Complete Unit - Silver Eagle

The warranty period is limited to two years from the date of retail purchase on behalf of the original owner of a Dixie Chopper Silver Eagle complete unit. This warranty will provide the cost of repair or replacement (at the discretion of Dixie Chopper) of the defective part.

Additionally, Dixie Chopper will provide to the original purchaser beyond the initial 2 year warranty as stated above, replacement of any stainless steel body due to rust; front fork and castor bearings, steering levers and linkages due to breakage for the useful life period the machine. This additional "lifetime warranty" covers stated parts only... no labor.

Deck Spindle Assembly

Parts and labor for the replacement of the complete deck spindle assembly (deck hub, deck spindle bearings, deck hub spacer, and blade spindle shaft), of the Dixie Chopper complete unit will be warranted for three years from the retail purchase date on behalf of the original owner against defects in materials or workmanship Hydro-Drive-Train-All Models (excluding Silver Eagles)

Hydro-drive components (pumps, wheel motors, and T-box), of the Dixie Chopper complete unit will be warranted for two years from the retail purchase date on behalf of the original owner against defects in materials or workmanship.

Hydro-Drive-Train -Silver Eagle

<u>Hydro-drive components</u> (pumps, wheel motors, and T-box), of the Dixie Chopper Silver Eagle complete unit will be warranted for two years from the retail purchase date on behalf of the original owner against defects in materials or workmanship.

Hydro-Drive-Train 3-Year Extended Warranty {Optional} {5 Year Coverage from Purchase Date}

Dixie Chopper offers for an additional fee (to be paid at the time of the unit purchase), a **3-year** extended warranty covering the hydro-drive system components of the standard warranty... plus all drive linkages, bushings, hoses, filtings, filter bases, oil reservoir, pumps & pulleys, T-box & pulley, wheel hubs, and wheel rims that require replacement due to a *defect in materials or workmanship*. {This extended warranty covers stated *parts only*... no labor.}

Engine- Kohler, Kawasaki, Honda, Yanmar

Engine warranty is provided by the engine manufacturer. Please refer to the engine manufacturer warranty statement included within the ownership materials provided with the unit. Dixie Chopper is not authorized to handle warranty adjustments on engines. Engine warranty claims must be filed with the appropriate engine manufacturer (Kohler, Kawasaki, Honda, Yanmar etc.) for necessary warranty repairs.

In general, engines used on Dixie Chopper units are warranted by the respective engine manufacturer for a period of two years from the retail purchase date on behalf of the original owner.

Engine- Guardian - Generac

The Guardian engines used by Dixie Chopper will be warranted for a period of three years from the retail purchase date on behalf of the original owner against defects in materials or workmanship. Labor required for engine warranty will be covered by Dixie Chopper for the 1st two years, and at the unit owners expense during the 3rd year.

Tires, Blades, and Belts

Tires, blades, clutch shoes, and belts are considered to be consumable-wear items, and are therefore warranted for an initial period of 90 days against materials or workmanship defects. not for wear or abuse.

Replacement Parts (Customer proof -of- purchase required)

Dixie Chopper replacement parts are warranted for 90 days against defects in materials & workmanship. (**Hydro pumps and motors must be dealer installed**) Coverage is for part replacement only... no labor, and does not pertain to improper installation or abuse.

Battery Warranty

Dixie Chopper original equipment batteries are warranted against OEM factory defects in materials or workmanship ("discharged only" and "abuse" are not covered). If battery failure occurs within 6 months of unit purchase date, battery will be replaced at no charge. Battery failures occurring beyond 6 months but less than 1 year from date of unit purchase will be replaced at 50% of the cost of the standard replacement battery.

Using a Dixie Chopper warranty claim, provide the OEM battery in-service decal/sticker showing the battery type (from top of battery) and affix it to the back side of the white copy of the warranty claim. Fill out the rest of the claim and submit to warranty department.

Transportation for Warranty Repairs

A Dixie Chopper complete unit (including any defective part(s)) requiring warranty repair, must be returned to an authorized Dixie Chopper Service Dealer within the warranty period. The expense of transporting the unit to and from the dealer for warranty work will be the responsibility of the unit owner.

Limitation of Warranty

The Product Registration/Dealer Delivery Certification must be mailed to Dixie Chopper within 3-days of the original retail purchase date to enable accurate validation of the warranty period provided. Proof of purchase may be required (invoice & copy of product registration) from the unit owner to substantiate any warranty claim. All warranty work must be performed by an authorized Dixie Chopper Servicing Dealer using only Dixie Chopper OEM parts.

This warranty covers only Dixie Chopper complete units that are registered with the factory when purchased new, properly maintained, and operated under conditions considered normal for commercial turf equipment.

Optional Extended Warranty Programs

5 Year Extended Guardian-Generac Engine Warranty (\$895) (5-Years Coverage from Purchase Date) This is an extension of the original three year warranty issued by Dixie Chopper and is subject to the same limitations. Please see Guardian Generac Engine owner's manual for details of the original warranty. This warranty will be administered by the Dixie Chopper Service/Warranty Department (800-307-2667). Dixie Chopper will, at its discretion, pay for (parts only), the replacement of the engine, or any of its components that fail due to defects in material or workmanship, for a period of five years from the original date of purchase.

<u>Five-Year Extended Hydro-Drive-Train Warranty</u> (5-Years Coverage from Purchase Date) Dixie Chopper offers a three-year (two -year on Silver Eagles) extended parts warranty covering hydro-drive-train components. This optional coverage is \$599 when purchased simultaneously with the new machine.

Purchasing the three-year extended parts warranty provides to the original purchased from date of purchase...

1st year Parts & Labor, 2nd year Parts Only, plus an additional 3-years Parts Only warranty coverage. This means for 5 years, if hydro-drive-train components (wheel motors, pumps & pulleys, T-box & pulley, hydro hoses, fittings, gaskets, drive linkages, bushings, wheel hubs, or wheel rims), as part of the machine, require replacement due to a defect in materials or workmanship, Dixie Chopper will cover the cost of needed replacement part(s). During the first year of warranty coverage, labor for the necessary replacement of the part(s) is included. During years 2 through 5, labor for the necessary replacement of the part(s) will be the responsibility of the machine owner.

Five Year Extended Deck Spindle Assembly Warranty(\$199) (5-Years Coverage from Purchase Date) This five year extended warranty covering the complete deck spindle assembly (deck hub, deck spindle bearings, deck hub spacer, and blade-spindle shaft), of the Dixie Chopper complete unit will be warranted for five years from the retail purchase date on behalf of the original owner against defects in materials or workmanship. The 4th and 5th year are parts only, no labor.

Dixie Chopper will replace all or part of the assembly at its discretion.

The Generac Engine, Hydro-Drive-Train, and Deck Hub Assembly warranties can all be purchased for \$1,495

The Hydro and Spindle Warranties can be purchased for \$798.

Please refer to the Dixie Chopper standard warranty for complete details. The Extended Warranties listed above are effective as of January 20, 2001

EXTENDED WARRANTY VERIFICATION

Dixie Chopper offers a drive-train extended warranty at the time the unit is purchased new and registered. 5 Year Extended Guardian-Generac Engine Warranty (\$895) (5-Years Coverage from Purchase Date) This is an extension of the original three year warranty issued by Dixie Chopper and is subject to the same limitations. Please see Guardian Generac Engine owner's manual for details of the original warranty. This warranty will be administered by the Dixie Chopper Service/Warranty Department (800-307-2667). Dixie Chopper will, at its discretion, pay for (parts only), the replacement of the engine, or any of its components that fail due to **defects in material or workmanship**, for a period of five years from the original date of purchase.

<u>Five-Year Extended Hydro-Drive-Train Warranty</u> (5-Years Coverage from Purchase Date) Dixie Chopper offers a three-year (two -year on Silver Eagles) extended parts warranty covering hydrodrive-train components. This optional coverage is \$599 when purchased simultaneously with the new

Purchasing the three-year extended parts warranty provides to the original purchaser from date of purchase...

1st year Parts & Labor, 2nd year Parts Only, plus an additional 3-years Parts Only warranty coverage. This means for 5 years, if hydro-drive-train components (wheel motors, pumps & pulleys, T-box & pulley, hydro hoses, fittings, gaskets, drive linkages, bushings, wheel hubs, or wheel rims), as part of the machine, require replacement due to a defect in materials or workmanship, Dixie Chopper will cover the cost of needed replacement part(s). During the first year of warranty coverage, labor for the necessary replacement of the part(s) is included. During years 2 through 5, labor for the necessary replacement of the part(s) will be the responsibility of the machine owner.

Five Year Extended Deck Spindle Assembly Warranty(\$199) (5-Years Coverage from Purchase Date) This five year extended warranty covering the complete deck spindle assembly (deck hub, deck spindle bearings, deck hub spacer, and blade-spindle shaft), of the Dixie Chopper complete unit will be warranted for five years from the retail purchase date on behalf of the original owner against defects in materials or workmanship. The 4th and 5th year are parts only, no labor.

<u>Dixie Chopper will replace all or part of the</u> assembly at its discretion.

The Generac Engine, Hydro-Drive-Train, and Deck Hub Assembly warranties can all be purchased for \$1,495

The Hydro and Spindle Warranties can be purchased for \$798.

Please refer to the Dixie Chopper standard warranty for complete details. The Extended Warranties listed above are effective as of January 20, 2001

ALL RETAILED MOWERS MUST BE REGISTERED TO PROCESS A CLAIM!

Properly completed claims (including all necessary information), will be processed within 15 working days.

WARRANTY CLAIMS SUBMISSION TO FACTORY

All Dixie Chopper warranty claims are to be submitted by utilizing Dixie Chopper Warranty Claim forms ONLY.

Please send in the top copy of claim form ONLY! (All other copies will be returned.)

Claim forms are available at *no charge* and may be requested when ordering parts.

Always retain and tag warranty-replaced parts until paid.

Tag information should include the Dixie Chopper Warranty Claim #, unit serial#, part#, owner & dealer names, as well as the date that warranty was filed. Dixie Chopper reserves the right to request <u>any part</u> to be returned for evaluation prior to processing the warranty. In such cases, the dealer will be notified promptly to return the requested part(s).

Factory-requested warranty parts returns not received at Dixie Chopper within 15 days will result in the warranty claim being rejected.

WARRANTY PARTS

warranty claim (PROTECTED) in the box.

All returned warranty parts must be received properly packaged and undamaged (due to freight).

Each section requires information pertinent to the warranty claim to enable claim processing... omission of information in any separate section of the claim (other than section # 10 for Dixie Chopper use) may cause the claim to be rejected due to the lack of required information. Properly filled-out claims will be processed within 15 working days of receipt at Dixie Chopper. <u>Double-checking</u> to provide all the necessary claim information *the first time* will insure a significant improvement in timely warranty credit for your dealership. Our goal is to make warranty processing simple, easy, and predictable for you... <u>we need your help</u> to accomplish this goal.
